Sports Development Authority of Tamil Nadu (SDAT), under the Youth Welfare and Sports Development Department, Government of Tamil Nadu invites applications from 09.07.2024, 10.00 AM to 29.07.2024, 05.00 PM from the eligible candidates who wish to join the services in the Sports Development Authority of Tamil Nadu (SDAT), as Sports Physiotherapist by direct recruitment. The candidates registered with Employment Exchange are also eligible to apply.

4. SELECTION PROCEDURE

All eligible candidates will be invited for the written examination which includes (i) Tamil Language test (ii) Test on Sports Physiotherapy which will be followed by Practical Test in Sports Physiotherapy. All the above tests will be conducted in Chennai. Distribution of marks for the above tests will be as below:

After evaluation of the above tests, eligible shortlisted candidates will be called for a personal interview which carries 40 marks,

- i. The list of shortlisted candidates for interview along with the date(s) and place of interview will be posted on the SDAT website.
- ii. The Candidates should note that their candidature at all the stages shall be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after the interview, it is found that they do not fulfil any of the eligibility conditions; their candidature shall be cancelled by the SDAT.
- iii. The Selection will be based on preliminary short listing of applications based on qualifications, followed by an interview. However, this is subject to modification by SDAT at any stage.
- iv. SDAT at its direction shall decide on the selection process, period of engagement, etc. Also, SDAT shall at any stage cancel or modify this selection process.
- v. All official communications regarding this selection process shall be made only through the email address or mobile number given in the application form by the candidate. All general notices shall be published only on the official website of SDAT.

The decision of SDAT in all matters regarding eligibility, selection and posting would be final and binding on all candidates. No representation or correspondence will be entertained by SDAT in this regard.

5. DOCUMENTS TO BE SUBMITTED ALONG WITH APPLICATION

- i. Passport size photograph
- ii. Photo identity proof (with the photo of the candidate clearly visible) issued by the competent authority viz, Aadhaar Card / Passport / Electoral Photo ID Card /Driving license. No other ID cards will be accepted.
- iii. 10th mark sheet
- iv. 12th mark sheet
- v. Community Certificate issued by competent authority

- vi. Special Category certificate (if applicable)
- vii. UG degree certificate
- viii. P.G. degree certificate
- ix. Experience certificate(s)

All these documents shall be submitted in original for verification as per the schedule to be intimated by SDAT.

6. GENERAL INSTRUCTIONS

- a. Before applying for the post, the candidate should ensure that he / she fulfils the eligibility criteria and other norms mentioned in this notification. Candidates are therefore advised to carefully read this notification and follow all the instructions given.
- b. The candidate shall send his / her application only after agreeing to all the terms and conditions mentioned in this document.
- c. Only Indian Nationals are eligible to apply.
- d. The selected candidate shall undergo two years of probationary period in accordance with the applicable rules.
- e. No person shall be eligible for appointment to any service by the above recruitment process unless he satisfies the appointing authority
 - i. that his character and antecedents are such as to qualify him for such service;
 - ii. that such a person does not have more than one wife living or if such a person is a woman, that she is not married to any person who has a wife living;
 - iii. Candidate selected for appointment to the post will be required to produce a certificate of physical fitness from a Registered Medical Practitioner.
- f. Correct and true information regarding arrest, convictions/debarment/disqualification by any recruiting agency, criminal or any disciplinary proceedings initiated or finalized, participated in agitation or any Political Organization, candidature in the election for Parliament/ State Legislature/Local Bodies etc., if any, should also be furnished to SDAT at the time of application along with the details thereof.
- g. Applications containing wrong claims relating to basic qualification/eligibility/

age/educational qualification will be liable for rejection.

- h. The decision of SDAT in all matter regarding the eligibility of the candidate, the stages at which such scrutiny of eligibility is to be undertaken, qualifications and other eligibility norms, the documents to be produced, mode of selection, date and time of selection and any other matter relating to this Recruitment is final.
- i. A candidate's admission to the interview and subsequent processes is strictly provisional. The mere fact that the call letter(s)/ attending interview by the candidate does not imply that his / her candidature has been finally cleared by SDAT.
- j. Any request for change of address, details mentioned in the submitted application will not be entertained subsequently.
- k. SDAT would be free to reject any application, at any stage of the process or cancel the candidature of the candidate in case it is detected at any stage that a candidate is found unfit for the post.
- l. Not more than one application shall be submitted by the candidate. In the case of multiple Applications, only the latest valid (submitted) application will be retained.
- m. Any candidate trying to exert any undue influence directly or indirectly shall be summarily disqualified.
- n. The candidate should ensure that the signatures appended by him/her in all the places viz. in his/her call letter, attendance sheet, etc. and all correspondence with SDAT in future should be identical and there should be no variation of any kind.
- o. A recent recognizable photograph should be affixed by the candidate in the application and the candidate should ensure that copies of the same are retained for use at various stages of the process.
- p. Intimations will be sent by email only to the primary email mentioned in the application form submitted by the candidates. Hence, the applicant shall enter a valid and functional mobile number and email ID.
- q. SDAT shall not be responsible if the information/intimation do not reach candidates in case of change in the mobile number, technical fault or otherwise, beyond the control of SDAT and the candidates are advised to keep a close watch on our authorized website (www.sdat.tn.gov.in) for latest

updates, till the recruitment process gets completed.

- r. The selection for appointment to the posts included in this recruitment is purely provisional subject to the final orders in the Writ Petitions, if any, pending before the Hon'ble High Court of Madras and Madurai Bench of Madras High Court, relating to this recruitment.

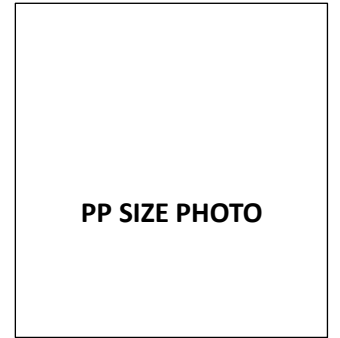
